### **OPENING REMARKS**

Mr. Roger TUPPER reminded the meeting that for any proposed changes to the
berthing guidelines, it should be discussed by the Pilotage Advisory Committee
Working Group (PACWG) before recommendations were made to PAC for
making the decision. Due to the urgency of the matter, the paper to be
discussed at this meeting had not gone through the PAC WG, and members
should be aware of this special arrangement and consider all the issues carefully.

(Mr. TUPPER left the meeting at this juncture.)

- 2. The Chairman welcomed all present. He extended particular welcome to Capt. LAM Wing-shing who was newly appointed as a PAC member in the capacity of a master mariner, and Mr. WU Ka-shun and Capt. YU Chi-leung who were attending the meeting on behalf of other members.
- 3. The Chairman told the meeting that Capt. David Watkins, Mr. SIU Wai-lim and Mr. TONG Ho-lok were not able to attend the meeting and had sent their apologies for absence.
- 4. The Chairman said that this special meeting was called to discuss the proposed new berthing guideline for large cruise ships transiting Victoria Harbour as it was anticipated that requests from large cruise ships to transit Victoria Harbour would continue to increase, and there was a need to thoroughly discuss the matter as soon as possible.

# **AGENDA ITEMS**

# I. Confirmation of Minutes of Last Meeting

5. The minutes of the last meeting were confirmed without any amendments.

#### **II.** Presentation of Paper

PAC Paper No. 3/2009 – "Movement of Large Cruise Ships Transiting Harbour"

- 6. Mr. Andrew NG briefed members on the proposed new berthing guideline for large cruise ships transiting Victoria Harbour, and invited comments from members. Mr. TSANG Man-ching said that he supported the proposal in principle, but asked if buoy B26 would be removed for large cruise ships of LOA greater than 270m. Mr. Raymond CHUNG replied that B26 would be kept vacant but not removed, so that more sea room would be provided to facilitate large cruise ships turning in the Northern Fairway. Mr. WU Ka-shun asked if only the red buoy would be removed for large cruise ships of LOA greater than 290m. Mr. CHUNG replied that two buoys, namely Northern 1 and Northern 2 in the Northern Fairway would be temporarily removed for large cruise ships turning into the Northern Fairway and Central Fairway. Northern 2 buoy was red and off the Stonecutters Island, while Northern 1 buoy was green and located to the northwest of the Macau Ferry Terminal.
- 7. <u>Capt. YU Chi-leung</u> said that the HKPA would like to propose the following amendments to the draft berthing guidelines at Annex IV of the paper:
  - i. As the guideline only applied to ships of LOA less than or equal to 345m, General Remarks item (6) should be deleted to avoid giving the wrong impression that ships of LOA greater than 345m were also included;

- ii. The sentence "1 patrol boat to clear the passage to Hung Hom" should be added to the Remarks under item 020.
- 8. Mr. John ELLIOT said that General Remarks item (6) appeared to be a general statement. The Chairman said that it was the normal practice for the pilots to carry out simulations and trials for the ships having LOA exceeding those specified in the berthing guidelines.
- 9. Mr. Terence SIT asked who would be paying for the costs of the removal of the buoy and how long the buoy would be removed for. The Chairman replied that the ship owners or their agents would be paying for the costs of the removal.

  Mr. Raymond CHUNG added that the buoy would be removed for about one day. In order to avoid carrying out the works in the dark, the buoy would be removed in the afternoon prior to the transit and be re-instated in the next day. Mr. John ELLIOT asked if a patrol boat would always be used. The Chairman replied that a patrol boat would be used as and when necessary. Members had no other comments on the paper. The Chairman concluded that the paper including the proposed amendments by the HKPA in para. 7 above was endorsed unanimously.
