Updates on the Latest Development of Municipal Solid Waste Charging

Purpose

This paper aims to brief members on the latest development of Municipal Solid Waste Charging (MSW charging) as well as the corresponding updates of the refuse collection modes for local vessels and ocean-going vessels and invite their comments to the Environmental Protection Department (EPD) and Marine Department (MD).

Background

2. Following the passage of the Waste Disposal (Charging for Municipal Solid Waste) (Amendment) Bill 2018 by the Legislative Council (LegCo) in August 2021, a preparatory period of 18 months has commenced. The Government is now proactively taking forward relevant preparatory work to enable the Government, various stakeholders and members of the public to get prepared for the implementation of MSW charging. As mentioned in the paper to LegCo Panel on Environmental Affairs in April 2022, depending on the work progress and the latest epidemic situation, our target is to implement MSW charging in the second half of 2023.

Charging Modes

- 3. In line with the "polluter-pays" principle, MSW charges are levied through the dual modes of (a) charging by pre-paid designated garbage bags (D-bags) / designated labels (D-labels) (charging by D-bags) and (b) charging by weight-based "gate-fee" (charging by weight). The charging mode applicable to a waste producer would depend on the waste collection service used by him/her. - 4. For the sales of D-bags and D-labels, EPD will establish a retail network comprising of few thousand retail outlets covering supermarkets, convenience stores, pharmacies and online platforms.

Refuse Collection Modes for Local Vessels

5. Currently, the marine cleansing services contractor of MD provides free of charge daily domestic refuse collection services to local vessels in typhoon shelters, anchorages and small boat anchorages. At the same time, the cleansing contractor distributes yellow plastic garbage bags to local vessels. After the implementation of MSW charging, with a view to tying in with the government policy, the MD's cleansing contractor will only collect the domestic refuse wrapped in the D-bags or oversized domestic refuse affixed with the D-labels in line with the statutory requirements, from local vessels.

Refuse Collection Modes for Ocean-going Vessels

6. Currently, the marine cleansing contractor of MD provides free of charge daily domestic refuse collection services to ocean-going vessels in the Victoria Harbour, Junk Bay and the Western Anchorages. Starting from 1 October 2022, MD will only arrange the marine cleansing services contractor to provide refuse collection services upon receiving the relevant service application. For those ocean-going vessels that would like to apply for the refuse collection services, they may call +852 2534 7227 or +852 2534 7228 during office hours, or send an email (email address: admpcu@mardep.gov.hk) to the Pollution Control Unit of MD at any time. applicant shall provide the necessary information, such as the quantity of domestic refuse to be collected (calculated in cubic metres), the name and location of the ship, etc., in the application. Furthermore, after the implementation of MSW charging, with a view to tying in with the government policy, MD's cleansing contractor will only collect domestic refuse wrapped in D-bags or oversized domestic refuse affixed with D-labels in line with the statutory requirements, from ocean-going vessels which have applied for refuse collection services.

Preparatory Work by Local Vessels

- 7. With a view to preparing for the implementation of MSW charging, person-incharge of local vessels or related organisations can take the following actions during the preparatory period:
 - (i) Understand the legislation requirements: Members of the public can understand the legislation requirements and implementation arrangements, with reference to the dedicated website of MSW

charging.

- (ii) Understand the charging mode of the places where vessels are located: As mentioned above, the applicable charging mode would depend on the waste collection mode of the relevant places. Members of the public can proactively approach their service contractors / property management companies (if applicable) to understand the waste collection mode of their premises during the preparatory period, so as to ascertain the collection and charging arrangements of the domestic waste of their vessels upon implementation of MSW charging.
- (iii) Cultivate the habit of waste reduction and recycling: Members of the public can reduce expenditure on MSW charging through proactively reducing waste at source and practicing clean recycling. If there are recycling facilities nearby, person-in-charge of local vessels and institutions can dispose of the sorted recyclables in the facilities according to the instructions.

Members of the public can also make good use of EPD's community recycling network "GREEN@COMMUNITY", which comprises 11 Recycling Stations, 32 Recycling Stores and over 120 Recycling Spots with services covering all 18 districts across the territory as well as Reverse Vending Machines (RVM), and deliver the sorted recyclables to these recycling points and practice recycling proactively in our daily lives. MSW Charging - Charging Modes

In line with the "polluter-pays" principle, MSW charges are levied through the dual modes -

- (a) charging by pre-paid **designated garbage bags** (**D-bags**) / **designated labels** (**D-labels**); or
- (b) charging by **weight-based "gate-fee"**. The charging mode applicable to a waste producer would depend on the waste collection service used by him/her.

(a) Charging by pre-paid D-bags & D-labels

- Applicable to most residential buildings, commercial and industrial buildings, village houses, street-level shops and institutional premises.
- The premise is using **any one of the waste collection services** below -
 - (i) Waste collected by the refuse collection vehicles (RCVs) of the Food and Environmental Hygiene Department (FEHD) or its contractors;
 - (ii) Waste collected by private waste collectors using RCVs with rear compactors; and
 - (iii) Waste disposed of by waste generators themselves / waste collection staff at the FEHD Refuse Collection Points.
- The mode of using D-bags / D-labels is also applicable to the domestic refuse collection services provided by MD to local vessels, which are moored in the typhoon shelters, anchorages and small boat anchorages; and ships in the Victoria Harbour, Junk Bay and the Western Anchorages.

Example: Disposal of domestic refuse by D-bags / D-labels

Local vessels are required to wrap their domestic refuse into D-bags before
disposing them to the MD's marine cleansing services contractor for collection.
For oversized refuse which cannot be wrapped into the D-bags, local vessels are
required to affix a D-label on the items before disposing.

(b) "Gate-fee"

- Mainly applicable to oversized waste or waste which is irregular in shape generated from commercial and industrial premises. When such waste is disposed of at the landfills and refuse transfer stations, a gate-fee will be charged based on its weight.
- Waste in the premise is collected by private waste collectors using refuse collection vehicles without rear compactors.
- The above mode is also applicable to the handling of oversized or large amounts of non-domestic waste.

Charging Details of D-bags & D-labels

The price of the D-bags is \$0.11 per litre, with nine different sizes for general use by the public, including t-shirt (3L-15L) and flat-top (20L-100L) designs.

D-labels are charged with a uniform rate of \$11 each.
