TERMS OF REFERENCE

- 1. To co-ordinate on behalf of Government arrangements in Hong Kong for the social and recreational welfare of all serving seamen, with the exception of those who are residing in Hong Kong. The term "serving seamen" is construed to mean "those seamen visiting the port and those temporarily residing here, consequent upon discharge for health or other reasons, awaiting re-engagement or repatriation".
- 2. To allocate any grants or monies which the Port Welfare Committee may receive from all sources for the social and recreational welfare of seamen.
- 3. To obtain information on developments and facilities in connection with seamen's welfare in other ports, and to take appropriate action in the light of this information.
- 4. To take such other action as it may see fit to promote the welfare of visiting seamen, including action in conjunction with other social and recreational bodies.
- 5. To publish an annual report and audited accounts.

REPORT

Introduction

The membership of the Port Welfare Committee (The Committee) is drawn from representatives of the local shipping community and government departments which are concerned with the welfare of visiting seafarers on ships calling at Hong Kong.

Objectives and Subventions

2. It is an international common practice for major ports to provide seafarers, who are away from home for prolonged periods at sea, with social and welfare services and onshore facilities that typically include affordable accommodation of reasonable standard and other leisure facilities. The Committee aims to ensure that proper arrangements are made to safeguard the welfare of and provide recreational facilities for visiting seafarers of all nationalities. In Hong Kong, such support services are provided by the Sailors Home and Mission to Seafarers (The Mission)¹ and Danish Seamen's Church, Hong Kong (The Church). These two organisations derive their income from the services they offer, such as restaurant facilities. In addition, The Committee's subventions are one of the sources of funds for them.

Finance

3. The Committee relies upon donations from the shipping and commercial community for its financial resources. The total amount of

donations collected in 2018-19 was \$167,890. In the same year, a subvention of \$150,000 was granted to The Mission and \$15,000 to The Church.

Shipping

4. Hong Kong is an international maritime centre and a regional hub port. It is one of the busiest ports in the world. In 2018, there were 350 400 vessel arrivals and departures at Hong Kong Port, involving 19.6 million twenty-foot equivalent units of containers and 259 million tonnes of cargo. The cross-boundary ferry and cruise passenger journeys exceeded 28 million.

Employment

5. The shortage of manpower is a subject of concern to the maritime industry in Hong Kong. The government and the industry have joined hands to train up local persons to help alleviate this shortage. A Sea-going Training Incentive Scheme² was set up in 2004 with an initial funding of \$9.0 million. An additional amount of \$19.2 million was granted by the government in 2009. Further amounts of \$12.4 million, \$4.38 million and \$4.64 million were granted in 2014, 2018 and 2019 respectively to the Scheme from the Maritime & Aviation Training Fund³. As at 31 March 2019, a total of 545 young persons had joined the Scheme; 216 deck and 108 engineer cadets had obtained Class 3 Certificate of Competency (CoC); 42 deck and 36 engineer officers had obtained Class 2 CoC; and 32 deck officers and 16 engineer officers had obtained Class 1 CoC. The result was encouraging.

6. In 2018, the chaplain and ship visitors of The Mission have been continually visiting vessel's crew both in Hong Kong Terminals in Kwai Chung



and by use of its motor launch in the anchorage. 2 929 ship crew have been visited, provided with welfare support and valued contact with crew and officers aboard. All seafarers are visited regardless of their race, creed or colour; all are treated equally and valued as fellow members of the maritime community. Services provided at these visits range from pastoral counselling, legal advice, contact with home, contact and communication with the shipping company or management (often overcoming language difficulties), transport to and from its seafarers centres (1 464 seafarers are transported from ship to shore free of charge), shopping, sightseeing and off the vessel BBQs, religious services particularly after a death on board, ship blessing and many other services - too small to name individually. Apart from daily visiting of ships, The Mission also actively visits all seafarers in hospitals in Hong Kong, helping them with communication to home, and providing them with anything which they may need during their stay and recovery. It is particularly important to visit seafarers in hospital. When other patients are receiving family and friends nearby, the seafarers can feel even more isolated than normal. A visit from the chaplaincy staff can help the seafarer feel wanted, respected and not alone. Of course nothing can replace a family member, and over the last year, The Mission has hosted many families of seafarers who are visiting Hong Kong to see their loved ones in hospital. In 2018, The Mission conducted 98 separate hospital visits and cared for 45 seafarers who were hospitalised in Hong Kong. Seafarers from 10 countries were taken to hospital in Hong Kong throughout the year, most of whom were from China, the Philippines, India and Indonesia and some were from Nepal and Sweden.

- 7. The Mission operates two Mariners' Clubs, one in Tsim Sha Tsui (TST) which is in the heart of the tourist area of Kowloon and the second is located right in the centre of "container port city" of Kwai Chung. The Kwai Chung facility is very accessible for those seafarers whose vessels are often only in port for a matter of hours whereas the TST Club is an ideal location for those seafarers who are leaving or joining their vessels and require accommodation. The TST Club is close to the shopping malls, the night markets and the downtown activity of the tourist nightlife. In March 2018, the half-century-old TST Club was closed for redevelopment. The redevelopment will allow The Mission to modernise the facilities of the TST Club for continuous provision of affordable welfare services to seafarers. There will be 75 bedrooms all en-suite, a heated swimming pool, conference facilities, a gym, a restaurant, a bar and a church along with chaplaincy services. redevelopment process will take about six years, during which a temporary Drop-in-Centre has been established at Wing On Plaza, East TST (Room 705). This facility provides a lounge with free WiFi for seafarers and a bag drop for those who wish to go shopping. Chaplaincy services are available during office hours. The facility also has a conference room that is available to the maritime community. Additional services to the crew of the cruise vessels calling at Kai Tak International Cruise Terminal have been launched since March 2019. A free shuttle service from 10am to 6pm providing hourly transfers from the terminal to East TST is in operation whenever there are cruise vessels visiting the terminal.
- 8. Kwai Chung was used by 4 645 seafarers as a drop in facility throughout 2018. The Mission runs a taxi/shuttle service from terminals to Kwai Chung Drop-in-Centre and back to anchorage time ashore. Even though shore leave is very short given the quick turnaround times in Hong Kong terminals, The Mission still manages to see a good number of seafarers at the centre.

In November 2018, The Mission held its 6th Annual Maritime 9. Charity Dinner and Annual Seafarers Awards. With over 260 participants attending the Dinner and Awards Ceremony, the event was again a great success. The awards this year attracted over 10 000 responses from seafarers serving on Hong Kong owned or managed vessels. The survey continued to ask questions about quality of life aboard and how the seafarers were treated by their employers. The survey has now become a benchmark which some companies are measuring how they are doing and has been greeted with more and more enthusiasm each year. The winners took to the stage at the event. Hong Kong Ship Owner of the Year 2018 was awarded to Wah Kwong Maritime Transport Holdings Ltd whereas Hong Kong Ship Manager of the Year 2018 was awarded to Fleet Management Ltd. It is planned to carry out the survey during the period from 1 July to 30 October 2019 for the Annual Maritime Charity Dinner and Seafarers Awards this year to be held on 14 November 2019. The charity part of the dinner has raised over HK\$850,000, 40% of which has been dedicated to the continuous work of the Mission in Yangon. Other funds have been sent to support The Mission in the Philippines for the seafarers' family assistance network.

Danish Seamen's Church, Hong Kong⁵

10. The Church has been established in Hong Kong for several decades since 1979. It helps the Danish ships arrive in Hong Kong with anything from dry socks to spiritual aid. The Church in Hong Kong is a branch of



Danish Seamen's Church in foreign ports. For more than a decade, the Church has sent chaplains and staff to major harbours around the world for providing church services, spiritual and welfare services to seafarers on board Danish flagged Ships.

- An old Danish shanty is about the loneliness of a seafarer on a seagoing vessel. The shanty is more than 80 years old, but it is truer now than before. Modern technology makes it possible to build even bigger ships and at the same time reduce the number of crew members on board. For economical reasons, the shipping companies shorten the time the ships stay at the harbour. Also for economical reasons, the shipping companies recruit manpower of different nationalities all over the world.
- 12. In the light of the above, The Church plays an indispensable role in providing quality welfare services to the seafarers. The Church visited about 230 ships in 2018-19. Before the ships arrive in Hong Kong, they often send The Church an email for help or assistance, such as requests for some groceries, DVDs or prizes for a raffle game on board. In collaboration with The Danish Government Seamen's Service called "Sea Health & Welfare", The Church is able to print fresh newspapers from all countries. When The Church visits the ships, The Church usually brings along newspapers covering languages of Danish, English, Filipino and Indian. The Church also provides the ships with books published in Danish, English and Polish. If the sailors have time and

opportunity to go ashore, The Church has "The Danish Room" on the third floor of the Mariners' Club in Kwai Chung. Fresh coffee and snacks are provided – A good opportunity for relaxation and conversation.

13. The Church would like to thank the Port Welfare Committee for their faithful support for The Church. The donation to The Church is an extremely welcome addition to The Church's rather tight budget.

PORT WELFARE COMMITTEE ACCOUNTING POLICIES AND EXPLANATORY NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2019

Reporting entity

Port Welfare Committee is a committee operated by the Marine Department of the Hong Kong Special Administrative Region. The Committee's registered office is located at 21/F, Harbour Building, 38 Pier Road, Hong Kong.

The Committee is a non-profit making body and its principal activity is to ensure that proper arrangements are made to safeguard the welfare of and provide recreational facilities for visiting seafarers of all nationalities.

1. Basis of preparation and accounting policies
