# **Redevelopment of the Mariners' Club**

4. It was noted that the proposal for the redevelopment of Mariners' Club at Tsim Sha Tsui had been cleared by the Executive Council and would be followed up by the Sailors' Home and Missions to Seamen.

#### **III.** Discussion Items

## (a) Accounts for the year ended 31 March 2016 (Appendix B)

5. The following financial position of the committee for the year ended 31 March 2016 as set out on page 2 of the financial statement which had been circulated to members before the meeting -

# (b) Recommended Donors List and Recommended Potential Donors List for 2016-17 (Appendices C & D)

- 6. The Chairman requested members to look into the Recommended Donors List (Appendix C) and the Recommended Potential Donors List (Appendix D) consolidated by the Secretary, both of which had been circulated to members together with the agenda of the meeting.
- 7. Members were invited to propose amendments or additional entries to the two lists. As appeal letters for donations in 2016-17 would be issued in November/December 2016, members' comments, if any, should reach the Secretary by mid-October 2016.

# (c) <u>Draft Annual Report for 2015-16 (Appendix E)</u>

8. The Chairman said that a copy of the draft Annual Report for 2015-16 had been sent to members before the meeting. The Annual Report would be sent to the potential donors to appeal for their donations which would mainly be used for supporting the two voluntary agencies, namely the Missions and the Danish Seamen's Church, Hong Kong. Members were invited to let the Secretary have their comments, if any, on the draft report by mid-October 2016.

# (d) Savings account of the Committee

9. The Chairman informed the meeting that a monthly service charge would be imposed by the HSBC on business savings account and current account if the deposit balance in any account was less than \$25,000. The Committee had a total sum of \$29,033 in these two accounts currently.

After discussion, the meeting agreed to close the savings account of the Committee with the HSBC to avoid the payment of the monthly service charges. The residual sum of about HK\$2,000 of the savings account would be transferred to the current account of the Committee upon completion of formalities with HSBC.

## **IV.** Any Other Business

## **Zika Virus Infection**

10. Dr Allen Chan of DH reported that there had been over 70 countries/areas reported cases of Zika Virus transmission. He stressed the need to remind seafarers to pay extra care when going to the affected areas and to practice safer sex as Zika Virus could also be transmitted by sexual contact. The factsheet on Zika virus infection were distributed to Members for information at the meeting. Copies of the factsheets would also be made available at the Mariner's Club for distribution to seafarers.

- 11. The next meeting of the Committee would possibly be held in March 2017. The Secretary would inform members of the details in due course.
