### Port Welfare Committee Appointment of New Auditor

#### **Background**

Albert Lam & Co Certified Public Accountants was appointed as the Honorary Auditor for the Port Welfare Committee (PWC) in 2004. In 2005, Albert Lam & Co. merged with another company under the name of "Hopkins CPA Limited". With the agreement of the PWC Hopkins CPA Limited was appointed as the Honorary Auditor for the PWC and has been providing free auditing service to the PWC since 2005. In the past few years, accounts audited by Hopkins CPA limited were submitted to the PWC for endorsement at its meeting in September. Thereafter, the audited accounts were incorporated into the annual report of the PWC, which was issued to potential donors to appeal for their donations.

After endorsement by the PWC at its meeting on 20 April 2007, the annual accounts of the PWC ending 31 March 2007 were sent to Hopkins CPA Limited for auditing in the usual manner. The auditor, however, replied that they would no longer provide free auditing service to the PWC and would charge HK\$5,000 for the service this year. The fee is exclusive of disbursements and out of pocket expenses which may arise in the course of the audit work. Copy of the letter from Hopkins CPA limited is attached at Appendix I.

## Proposal

3. There is no statutory provision, regulation or instruction governing auditing of the fund managed by the PWC. In accordance with the prevailing Standing Accounting Instructions of the Hong Kong Government on management of non-government funds, a non-government fund may be audited by a public officer at a rank not lower than Accounting Officer II of the Hong Kong Government or equivalent and independent of the management of the fund if the average fund balance or the total payments during the accounting period of the statement do not exceed HK\$2 million.

- 4. In the case of the PWC the average balance of the fund is about \$250,000 and the total payments per year are about \$115,000. In these circumstances we consider that it would be in the interest of the PWC to appoint a public officer to audit the statement of receipts and payments for the PWC fund because it would ensure provision of continuous auditing service to the PWC.
- 5. It is proposed that the Internal Auditor of the Marine Department be appointed as the Honorary Auditor for the PWC with immediate effect. The Internal Auditor is a public officer of the Treasury Accountant grade which is at a rank higher than the Accounting Officer II and independent of the management of the PWC fund.

#### **Advice Sought**

6. The Chairman and Members are requested to advise whether they agree to the appointment of the Internal Auditor of the Marine Department as the Honorary Auditor of the PWC with immediate effect by completing and returning the attached reply slip (Appendix II) to the Secretary of the PWC on or before 8 June 2007 either by fax (Fax no. 2541 7194) or by mail to the following address-
