INTERNATIONAL CONVENTION ON CIVIL LIABILITY FOR BUNKER OIL POLLUTION DAMAGE, 2001

Accession by Sierra Leone

Entry into force

The Secretary-General of the International Maritime Organization has the honour to refer to the International Convention on Civil Liability for Bunker Oil Pollution Damage, 2001, and to state that, with the deposit of an instrument of accession by the Republic of Sierra Leone, on 21 November 2007, the requirements for the entry into force of the Convention, as set out in article 14, were fulfilled:

Article 14 of the Convention provides as follows:

"(1) This Convention shall enter into force one year following the date on which eighteen States, including five States each with ships whose combined gross tonnage is not less than 1 million, have either signed it without reservation as to ratification, acceptance or approval or have deposited instruments of ratification, acceptance, approval or accession with the Secretary-General."

Therefore, in accordance with the provisions of article 14, the Convention will enter into force on 21 November 2008, i.e. one year following the date on which the requirements for entry into force were met.

A list of the eighteen Contracting States to the Convention, showing their approximate individual gross tonnages, which combine to form approximately 15.86% of the world's merchant shipping, appears overleaf.
