Marine Site Investigation to the South of Ma Wan

With immediate effect and for a period of approximately six months, marine site investigation works involving sampling of subsea soil, drilling of vibrocores, boreholes and cone penetration tests will be carried out in the following works areas:

Works Area 1: This area is bounded by straight lines joining the following coordinates (WGS 84 Datum) from (A) to (I) and the adjacent shoreline:-

Works Area 2: This area is bounded by straight lines joining the following coordinates (WGS 84 Datum) from (J) to (M) and the adjacent shoreline:-

(L)	22° 20.351'N	114° 03.470'E
(M)	22° 20.303'N	114° 03.371'E

2. The works will be carried out by two flat-top barges and two jack-up barges. One tugboat and one work boat will provide assistance. Vessels engaged in the works will display signals as prescribed in international and local regulations.

- 3. A working area of approximately 50 metres around each barge will be established. Yellow marker buoys fitted with yellow flashing lights will be laid to mark the positions of the anchors extending from each flat-top barge. Yellow flashing lights will be installed at the four corners of each jack-up barge to indicate its position.
- 4. The hours of work will be from 0700 to 1900 hours. No works will be carried out on Sundays and public holidays. Vessels employed for the works will stay in the works areas outside the hours of work.
- 5. Vessels navigating in the vicinity should proceed with caution.
- 6. A drawing showing the works areas is attached to this Notice. This Notice is an extension of Marine Department Notice No. 32/2024.


