Various "Non-return drain valve / pipe" for the Cargo Holds were found lost and inoperable. (including the units adjacent to the STBD side of the Cargo Holds No.1(FWD), No.3, No.4 are completely lost; The units adjacent to PORT side of Cargo Hold No.3 was found with alterationetc.). Most of the units were found with severe corrosion wastage, non-return ball valves stuck and blocked, the designate Fire Caps were lost (without effective means of closing for cargo hold fire-fighting). 6. By objective evidence of the indicated deficiencies in the inspection, the SMS implementation was failed to ensure the shipboard maintenance, without adequate resources. The Accommodation Air Conditioning (A/C) System was found not intact (with numerous open gaps), the A/C wentilation was taking air suction from the interior and formed with vacuum (in resisting the A/C Room fire door closure). 4. By objective evidence of the indicated deficiencies in the inspection, the SMS implementation was failed to ensure the shipboard operation, maintenance and emergency preparedness, without adequate resources and equipment under the Ship Management (DOC) Company Responsibility. External Audit shall be performed by the R.O.
