Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the “Chairman, Central Tender Board” and placed in the Government Secretariat Tender Box, situated at Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12:00 noon (Hong Kong time), on 14 March 2025 (Friday). Late tenders or submission by fax, or tenders not deposited in the specified tender box will not be accepted.

Tenderers can submit tender via the e-TS. Tenderers should allow sufficient time for complete data transmission before 12:00 noon (Hong Kong Time) on 14 March 2025 (Friday) when submitting their Tenders via the e-TS as specified in
