Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the “Chairman, Tender Opening Committee, Government Logistics Department” and deposited in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12:00 noon (Hong Kong time), on 16 September 2024 (Monday). Late tenders or submission by fax, or tenders not deposited in the specified tender box will not be accepted.
