**本地載客船隻安裝雷達資助計劃**  
**(延長申請期限)**

**目 的**

本資料文件載述有關延長題述資助計劃的申請期限的安排，請各委員備悉。

**詳 情**

2. 本地船隻諮詢委員會（「委員會」）在 2014 年 4 月 25 日的會議通過要求在本地球隻安裝船舶自動識別系統（英文簡稱「AIS」）、雷達和甚高頻無線電話的建議。相關的法例修訂已於 2016 年 12 月 9 日刊憲，而有關的先訂立後審議的立法程序已於 2017 年 2 月 8 日完成。有關於第 I 類別船隻上安裝及操作雷達的規定將於 2017 年 12 月 1 日實施生效。

3. 為減輕業界就安裝雷達而需額外承擔的成本，海事處已於 2015 年 12 月推出題述資助計劃。每艘合資格船隻可以實報實銷的方式獲資助安裝合規格雷達的半額費用（即購買及在船上裝置合規格雷達費用的半額），但以港幣 31,000 元為可獲支付的資助上限。有關詳情載列於委員會會議文件第 16／2015 號（*附件一*）。

4. 委員曾於 2016 年 12 月 30 日第 21 次委員會會議上，表示部分船東因安裝的雷達並未符合海事處相關的要求，而未能就其安裝的雷達申請資助。委員表示希望海事處可延長題述資助計劃的申請期限，便利業界善用資助，以安裝符合相關要求的雷達。

5. 相關的法例修訂旨在提升海上安全，而題述的資助計劃則旨在減輕業界就安裝雷達而需額外承擔的成本，從而協助業界符合法例修訂中所訂明的新規定。海事處經考慮委員會的意見、業界的實際需要以及迄今所收到的申請宗數後，同意將題述資助計劃的申請期限由 2017 年 3 月 31 日延長至 2017 年 9 月 30 日。至於題述資助計劃的申請資格、資助限額、申請安排以及申請人接受資助時所需作的承諾，則維持不變。就有關細節，請參閱 **附件一**。

## 本地船隻諮詢委員會

### 本地載客船隻安裝雷達資助計劃

#### 目的

本文件載述本地載客船隻安裝雷達資助計劃的詳情。

#### 背景

2. 為防止日後再發生相類撞船事故，《2012年10月1日南丫島附近撞船事故調查委員會報告》建議應規定所有獲准載客超過100人的船隻須安裝雷達。<sup>1</sup>

3. 本地船隻諮詢委員會在2014年4月25日的會議通過在本地船隻安裝船舶自動識別系統（AIS）、雷達和甚高頻無線電話的建議，亦備悉海事處會全額資助本地船隻安裝AIS及半額資助本地船隻安裝雷達。<sup>2</sup>

#### 資助安裝雷達計劃詳情

##### 申請期限

4. 申請期限擬訂於2016年1月1日至2017年3月31日（首尾兩日包括在內）。

##### 申請資格

5. 符合下列條件之船隻（“合資格船隻”）的船東或其代理人可向海事處提出申請：

- (a) 獲海事處發牌可運載超過 100 名乘客的第 I 類別船隻；
- (b) 並非獲發牌為“水上食肆”或“固定船隻”；
- (c) 並無任何牌照或許可限制該船隻只可在避風塘範圍內往來航行；
- (d) 並非符合下述第(i)至(iii)項的船隻：
  - (i) 有任何牌照或許可限制該船隻只可在維多利亞港口界線以內往來航行；
  - (ii) 經營《渡輪服務條例》(第 104 章)所界定的專營服務或領牌服務；和
  - (iii) 沒有獲得航速管制豁免；
- (e) 並無任何法例條文或任何牌照或許可條件已要求該船隻裝設有雷達；和
- (f) 在船隻上安裝有一台雷達，而該台雷達是在 2014 年 4 月 25 日或之後安裝並符合《工作守則-第 I、II 及 III 類別船隻安全標準》附件 I-4 所載列的技術規格。

### 資助限額

6. 每艘合資格船隻可以實報實銷的方式獲資助安裝合規格雷達的半額費用（即購買及在船上裝置合規格雷達費用的半額），但以港幣 31,000 元為可獲支付的資助上限。

### 申請安排

7. 申請人須連同申請表格附上以下文件，以茲證明：

- (a) 購置及在船上裝置雷達費用的單據；

(b) 由雷達供應商或裝置商發出確認雷達已安裝在船隻上的陳述或證明；及

(c) 由雷達製造商、供應商或裝置商發出確認安裝在船隻上的雷達符合合規格雷達的技術規格的陳述或證明。

8. 船東或其代理人可在安排船隻的首個檢驗或複驗日之前的最少三個工作天向海事處提出申請，海事處人員會在收到申請起計三個工作天後就有關船隻進行的首個檢驗或複驗，檢查船隻是否已裝設有合規格雷達。如申請人在少於船隻首個檢驗或複驗前三個工作天提交申請，海事處會在該次船隻檢驗或複驗之後的下一次船隻檢驗或複驗時才檢查船隻是否已裝設有合規格雷達。經海事處人員在船隻檢查後，信納有關合規格雷達的安裝符合資助計劃的所有條件，海事處方會向申請人支付資助款項。

#### 接受資助承諾

9. 如申請人獲得資助，須承諾不得隨意拆除在船隻上的合規格雷達，並確保航行時船上有合資格操作雷達的船員以操作雷達。申請人亦須維修保養在船隻上的合規格雷達，並在雷達變得不能使用時通知海事處。

#### **本地船隻檢驗工作小組委員會<sup>3</sup>**

10. 在本地船隻檢驗工作小組委員會的 2015 年 10 月 22 日會議上，有委員憂慮未能在申請期限前培訓或聘請足夠合資格操作雷達的人士，認為應放寬申請期限。

11. 就培訓方面，理解坊間經調整的雷達操作（本地水域）培訓課程已在 2014 年 10 月開始開辦。根據課程開辦者提供的資料，截至 2015 年 10 月，約有 91 人已成功修畢該課程。海事處估計約有 40 至 50 艘本地船隻可申請雷達資助，認為業界已逐漸有合資格操作雷達的人士，故此目前的申請期限

已給予足夠時間讓合資格的申請人提出申請。海事處會密切留意情況發展，並視乎立法進度，有需要的時候會考慮是否延展申請期限，但現階段呼籲合資格的申請人應儘早申請資助。

4. 申請人在提交申請當日須為符合下列條件的本地船隻的船東或其代理人：
  - (a) 獲發牌可運載超過 100 名乘客的第 I 類別船隻；
  - (b) 並非以水上食肆或固定船隻領有證明書；
  - (c) 並無任何由政府發出的牌照或許可條件限制該船隻可在避風塘範圍內往來航行；
  - (d) 並無任何法例條文或任何由政府發出的牌照或許可條件規定該船隻須安裝雷達；
  - (e) 並非符合下述第(i)至(iii)項的船隻：
    - (i) 有任何牌照或許可限制該船隻只可在維多利亞港口界線以內往來航行；
    - (ii) 經營《渡輪服務條例》(第 104 章)所界定的專營服務或領牌服務；及
    - (iii) 沒有獲得航速管制豁免；及
  - (f) 在船上安裝有一台合規格雷達，而該台合規格雷達是在 2014 年 4 月 25 日或之後安裝。
5. 申請人可為個人或香港註冊公司。

#### General

1. Each application form shall be used for one vessel only.
2. Unless otherwise stated, this form could be completed in either English (block letters) or Chinese.
3. Application period is between 1 January 2016 and 30 September 2017 (both dates inclusive). Late application will not be accepted under any circumstances.

#### Eligibility

4. The applicant shall be an owner or his agent of a local vessel which as at the date of submission of application –
  - (a) is a Class I vessel licensed to carry more than 100 passengers;
  - (b) is not certificated as a floating restaurant or stationary vessel;
  - (c) is not restricted under any condition of any licence or permit issued by any Government department to ply only within the boundaries of a typhoon shelter;
  - (d) is not already subject to a requirement of installation of radar on board under any statutory provision or any condition of any licence or permit issued by any Government department; and
  - (e) is not a vessel which satisfies the following –
    - (i) the vessel is restricted to ply within the boundaries of the Victoria port under any licence or permit;
    - (ii) the vessel operates a franchised service or a licensed service as defined in the Ferry Services Ordinance (Cap 104); and
    - (iii) the vessel has not been granted exemption from speed restriction; and
  - (f) is installed with one piece of Conformed Radar which was installed on or after 25 April 2014.
5. The applicant may be an individual person or a Hong Kong registered company.

6. 資助是以每艘船隻為對象。不論船隻的擁有權有否變更，任何符合上文第4段的本地船隻只可獲資助一次。
7. 海事處就是否發放任何資助留有最終決定權。

### 資助

8. 海事處會考慮會否以實報實銷的方式資助合資格船隻安裝合規格雷達的實際開支，包括合規格雷達的設備成本和安裝費用，總可獲支付的資助上限為31,000元。

### 申請手續

9. 申請人可親身將申請表送交或郵寄至海事處本地船隻安全組（地址：香港中環統一碼頭道38號海港政府大樓23樓2312室）。
10. 已填妥的申請表須附上下列文件：
  - (a) 申請人的香港身份證副本或公司註冊證書副本；
  - (b) 船隻擁有權證明書副本；
  - (c) 船隻運作牌照副本；
  - (d) 由雷達供應商或裝置商就船上已安裝雷達發出的報告；
  - (e) 由雷達製造商、供應商或裝置商發出，核證或確認船上安裝的雷達符合上文第4(f)段合規格雷達的規格的證明；
  - (f) 由通訊事務管理局就船上安裝的雷達發出的海上無線電（本地船隻）牌照；及
  - (g) 雷達設備成本及安裝費用的單據正本。
11. 如海事處在進行檢驗前至少三個工作天收到填妥的申請，海事處會在該檢驗查核船隻上是否已妥當安裝合資格的雷達（“有關查核”）。
12. 如海事處在進行檢驗前少於三個工作天收到填妥的申請，海事處不會在該檢驗作有關查核，船隻須待其後的檢驗才獲作有關查核。

6. The subsidy to be granted is vessel-specific. Any local vessel which complies with paragraph 4 above is entitled to the subsidy once only, irrespective of whether there has been a change in the ownership of the vessel.
7. The Marine Department retains the final discretion to decide whether to grant any subsidy.

### Subsidy

8. The Marine Department will consider whether to subsidise the actual cost of installing a Conformed Radar on an eligible vessel, covering both the equipment cost of the Conformed Radar and the installation fee on an accountable basis (i.e. on the basis of the actual cost and fee incurred), subject to a maximum limit of \$31,000 as the total amount of subsidy payable.

### Application Procedure

9. An application may be submitted in person or by post to the Local Vessels Safety Section, Marine Department, Room 2312, 23/F, Harbour Building, 38 Pier Road, Central, Hong Kong.
10. The completed application form must be accompanied by the following documents –
  - (a) a copy of the applicant's Hong Kong Identity Card or Certificate of Incorporation;
  - (b) a copy of the Certificate of Ownership of the vessel;
  - (c) a copy of the Operating Licence of the vessel;
  - (d) a report on the installation of radar on the vessel issued by the radar provider or installer;
  - (e) a statement issued by the radar manufacturer, provider or installer certifying or confirming that the radar installed on the vessel is in conformity with the specifications set out paragraph 4(f) above;
  - (f) a copy of the Maritime Radio (Local Vessel) Licence issued by the Communications Authority in respect of the radar installed on the vessel; and
  - (g) the original fee receipt(s) of the radar indicating the equipment cost and installation fee.
11. The Marine Department will assess whether a Conformed Radar has been properly installed on the vessel (“Assessment”) when, if a duly completed application is received by the Marine Department at least three working days before a survey is due to take place, the vessel undergoes the Assessment at that survey.
12. If a duly completed application is received by the Marine Department less than three working days before a survey is due to take place, no assessment will take place at the upcoming survey, and the

vessel will need to wait to undergo the Assessment at a later survey.

13. 如海事處信納 –

“Victoria port” means the area of the waters of Hong Kong declared under section 56 of the Shipping and Port Control Ordinance (Cap 313) as Victoria port.
